Call to Order and Approval of Agenda



Commissioner Storie then made a motion to appoint Zachary Pittman as Yancey County Deputy Tax Collector to serve a term to expire on June 30, 2012. The motion was seconded by Chairman Savage and the vote to approve was unanimous. Commissioner Riddle then made a motion to appoint Jeff Boone as Yancey County Tax Assessor to fill the unexpired term of Susie McEntyre which expires on June 30, 2012. Commissioner Storie seconded the motion and the vote to approve was unanimous.

Adjournment


Having no further business Commissioner Storie made a motion to adjourn and it was seconded by Chairman Savage. The vote to adjourn was unanimous.




